



INTERNET POLICY

Internet Usage

Velocity Maritime Services Pvt. Ltd. provides you internet facility on board as part of the welfare program promoting communication with family and friends.

You are solely responsible for the activity that occurs on your account, and you must keep your account password secure. You must notify **VMS** Ship Management immediately of any breach of security or unauthorized use of your account.

Subject to the terms and conditions of this agreement, **VMS** grants you permission to use the Service for your personal, non - commercial purpose only. You agree not to engage in any of the following prohibited activities:

- (i) copying, distributing, or disclosing any part of the Service in any medium, including without limitation by any automated or non automated “scraping”;
- (ii) using any automated system, including without limitation “robots,” “spiders,” “offline readers,” etc., to access the Services in a manner that send more request messages to the servers than a human can reasonable produce in the same period of time by using a conventional on – line web browser;
- (iii) Attempting to interfere with, compromise the system integrity or security or decipher any transmission to or from the servers running the service;
- (iv) Taking any action that imposes, or other software agents through the Services;
- (v) Uploading invalid data, viruses, worms, or other software agents through the service;
- (vi) collecting or harvesting any personally identification information, including account names and email addresses;
- (vii) using the service for any commercial solicitation purposes;
- (viii) using any information obtained from the service in order to harass, abuse, or harm another person, or in order to contact, advertise to, solicit, or sell to any Member without their prior explicit consent,
- (ix) impersonating another person or otherwise misrepresentative your affiliation with a person or entity, conducting fraud, hiding or attempting to hide your identity;
- (x) bypassing the measures we may use to prevent or restrict access to the service.
- (xi) Sending, receiving or accessing explicit pornographic and gambling material.

Velocity Maritime Services Pvt. Ltd. may permanently or temporarily terminate, suspend, or otherwise refuse to permit your access to the service without notice and ability for any reason, including if in **VMS**'s sole determination you violate any provision of this Agreement .



User Content

This Service allows Users to post reviews, comments, questions, and other information (“User Content”). You are solely responsible for your User Content that you upload, publish, display, link to or otherwise make available (hereinafter, “post”) on the Service.

You agree not to post User Content that:

- (i) Is confidential or defamatory to the vessel, company, its product / services, colleagues, authorities and or customers.
- (ii) May create a risk of harm, loss, physical or mental injury, emotional distress, death, disability, disfigurement, or physical or mental illness to you, to any other person, or to any animal or property;

- (v) Contains any information or content that we deem to be unlawful, harmful, abusive, racially or ethnically offensive, defamatory, infringing, invasive of personal privacy or publicity rights, harassing, humiliating to other people (publicly or otherwise), libelous, threatening, profane, or otherwise objectionable;
- (vi) Contains any information or content that is illegal or content that you do not have a right to make available under any law or under contractual or fiduciary relationships ; or
- (vii) Contains any information or content that you know is not correct and current.

You are solely responsible for your interactions with others. **VMS** reserves the right, but is not obligated, to reject and / or remove any user content that **VMS** believes, in its sole discretion, violates these provisions.

VMS takes no responsibility and assumes no liability for any user Content that you or any other Users or third parties post or send over the service. **VMS** is not responsible for any public display or misuse of your User Content. **VMS** will co-operate with authorities should they decide to prosecute any crew member for posting offensive information or committing frauds.

Access to the internet through the company and the ship is a privilege and all employees must adhere to the policies concerning computer, email internet usage. Violation of these policies could result in disciplinary and / or legal action leading up to and including termination of employment.
